Participant Declaration – Deed of Waiver & Indemnity

I, _____, hereby agree with Tooradin Dirt Drags (TDD) that I am by this agreement entitled to participate in the motorcycle activity/meeting on the terms and conditions set out in this document.

1) ACKNOWLEDGEMENT OF RISKS, DANGERS AND OBLIGATIONS

- a) I DO ACKNOWLEDGE THAT motorsport contests and activities involving machinery, speed and potential body contact and participating in the various ancillary processes are dangerous undertakings, and in doing so I realise that I am participating at my own risk.
 - i) I and any persons engaging in such activities are exposed to serious risks by way of the nature of the hazards of active motorsport and participating in activities involving the multiple contestants, vehicles and high speed movement and the general hazards of motorsport contests.
 - ii) I understand that the very nature of these activities and being in this environment exposes myself and those with me to potentially serious and even life threatening risks.
 - iii) I am aware that I, in any activity carried out by or under the auspices of the TDD, am only allowed to do so on the distinct and clear understanding that I do so at my own risk. I have inspected the facilities and accept same as is, whereis.
 - iv) I understand I have the responsibility to protect myself by wearing safety clothing and safety accessories such as a helmet and eye protection material in order to minimise any injury to my person.
 - v) I accept those risks of my own volition, I am responsible for my safety and the safety of those around me.
- b) I DO ACKNOWLEDGE THAT of my own free will and desire I have contracted with the provider of these services to enable my active participation in the events and associated activities, including potentially dangerous undertakings, and that I have read and clearly understand the warnings.
 - i) I assume all the risks whatsoever entirely, and hold all those involved free from any and all liability, actions, litigation whatsoever, or claim debt or demand of every and any nature whether arising from contract or resulting from in any way my free association with, and free participation in such activities.
 - ii) I fully understand the risks, I fully understand my rights, I fully understand that I give up those rights and assume all of those risks personally.
 - iii) I do so at my own risk, willingly and knowingly.
- c) I acknowledge clearly and with full understanding at law, that this warning, waiver, agreement and assumption of risk shall be a full and complete release and indemnification for myself, my heirs, families, executors and assigns for all time.

2) INDEMNITY AND RELEASE GIVEN TO ORGANISERS AND PROPERTY OWNER

In consideration of the acceptance of me as a participant in the Meeting:-

- a) I agree to indemnify and keep indemnified to the full extent permitted by law those indemnified and each of them in the following manner;
 - i) That I participate in the meeting at my sole risk and responsibility;
 - ii) That I accept the Venue as it stands with all or any defects hidden or exposed;
 - iii) That I have an obligation to myself and to others to act safely and within the rules and regulations of motorsport competition.
 - iv) That those persons and organisation indemnified do not make any warranty that the services of the Meeting will be provided with due care and skill or that any materials provided in connection with the services will be fit for the purpose for which they are supplied;
 - v) That I indemnify and hold harmless those indemnified, their respective servants, agents, officials and competitors, against any actions, costs, losses or claims which may be made by me or on my behalf for or in respect of or arising out of my death or any injury loss or damage caused to me or my equipment whether cause by negligence, breach of contract or in any other manner whatsoever.

- vi) I have voluntarily made and understood this warning and accept and assume the inherent risks in participating in this Event.
- b) It is a condition of participation in these activities and access to TDD services, facilities and premises, that the property owners, committee, members and facilitators, their servants and agents, whatsoever are absolved by me from all liability, howsoever arising, from injury or damage howsoever caused (whether to property, person, fatal or otherwise) arising out of my participating in these activities, or using our services and/or facilities, or in any way whatsoever due to accident, mishap, negligence, breach of duty, default and/or omission on the part of the owners, committee, members and facilitators, servants or agents, contractors and or invitee's.
 - i) That my participation and TDD conducting the activities for me serves as consideration to effect this agreement/release.
- c) I agree to release to the full extent permitted by law those indemnified and each of them from all liability to me for any claim, loss, damage, cost or expense (whether arising under statute, from negligence, personal injury, psychological trauma, death, property damage or infringement of third party rights or otherwise) that arise s as a result of any act, matter or other thing done, permitted or omitted to be done by me or which is in any way connected with my presence at or involvement in the Event.
- d) The release and indemnity provided by me in this declaration is in addition to, and will not in any way limit the application of, the conditions of sale attaching to tickets, conditions of entry, conditions of credentials or any other applicable term or conditions in respect of the Event.

3) MEDICAL

- a) I declare that I am and continue to be medically and physically fit and able to participate in the Meeting. I will immediately notify TDD in writing of any change to my fitness and ability to participate. I understand and accept those indemnified will continue to rely upon this declaration as evidence of my fitness and ability to participate.
- b) I acknowledge and agree that if required, those indemnified may arrange medical or hospital treatment (including ambulance transportation) for me. I authorise such actions being taken by those indemnified and agree to meet all costs associated with such action whatsoever. I understand it is compulsory for the cost of ambulance insurance in some form and I accept responsibility for the cost of the ambulance transportation, ambulance cover and further agree to maintain ambulance cover during the term of my participation.

4) RIGHT TO USE IMAGE

Right to use image I acknowledge and consent to photographs and electronic images (including, but not limited to, moving images) being taken of me during my participation in the Event. I acknowledge and agree that such photographs and electronic images are owned by TDD and it may use the photographs and electronic images for promotional or other purposes without further consent being necessary.
